Image enhancement and security updates

he West Chester Commercial BID board and Groundwork have completed a number of feasibility assessments into image enhancements and more recently a CCTV project for the estate following the offer of a grant towards a system from Cheshire West and Chester Council.

The CCTV system proposal for a camera at the entrance to the BID linked into the local authority's borough wide CCTV system has not been approved as it did not demonstrate value for money or an effective solution for tackling issues around crime.

The offer of the grant from the Council is still in place for a time limited period, and the Board with Groundwork are developing options for a lower cost ANPR system similar to the types used on other estates in Cheshire. A decision about the ANPR system will be taken during September and reported to businesses in November at the AGM.

Since the start of the BID, a priority has been tackling challenges around the image of the estate. The BID has delivered a number of successes in the first couple of years of the BID including litter picks, new street name plates and working with Cheshire West and Chester Council to improve the standards cleansing and upgrading of nameplates. In addition there have been some highway improvements on Sovereign Way. The Board and Groundwork however recognise that much more can be done to lift and enhance the image of the estate in the next three years of the BID.

During the last 6 months, proposals for three image enhancement projects have been developed, however due to the complexity of statutory services entering the West Chester Commercial BID area these projects are having to be modified before implementation. The BID Board also committed in their most recent meeting in August to deliver a wider spread of smaller scale image enhancement projects and more pro-actively tackle the opportunities for improvements across a wider mix of public / private land that makes up the BID area.

The first step to deliver this is already underway, with small scale improvements at sites being scoped out during August and September. The next step will be the development of a portfolio of small scale image enhancement projects that we expect to present at the AGM in November and begin implementing over the winter period.
