BID funds security measures across the estate

he West Chester Commercial **Business Improvement District** (BID) has funded a number of security measures over recent weeks to help make the estate a safer, more secure place for businesses and their employees.

Please see below and right for a full range of initiatives that have been provided by West Chester Commercial BID which include:

- The introduction of SelectaDNA marking kits which a large number of businesses have now received from BID Officer Mark Henshaw. SelectaDNA is a forensic marking system which comes in kit form for domestic and commercial use. The product contains a liquid specifically DNA-coded to each individual customer or company, and which can be easily applied to any items of value. The liquid also contains thousands of unique microdots, allowing the Police two ways to identify marked items. If equipment is stolen and later found, Police can link it directly with the crime scene. By placing SelectaDNA signage around your premises, it is proven to reduce your chances of being a victim of theft and burglary by up to 85%. Please ensure you mark up your valuables and display the sign in your premises.
- The setting up of the Rapid Text Service. The Rapid Text Service enables business owners to report real time suspicious activity which is then communicated to the estate.

If you haven't already registered, please do so by telephoning the Rapid Text Service on 01606 866658 and providing a company mobile phone number where information can be messaged. Alpha Omega Securities are linked to this service. It is available 24/7, 365 days a year.

Mobile Security Patrols. Following a tender process, Alpha Omega Securities have been appointed to deliver the mobile security patrol service across the estate during Christmas, New Year and bank holiday periods throughout the calendar year. The first of these patrols commenced on Friday 22nd December 2017 at 6pm through to Tuesday 2nd January 2018 at 6am.

The mobile patrols include both car and foot patrols. It would be helpful if businesses could provide Alpha Omega with an emergency contact number for their company as this will allow them to make contact directly if any issues occur with any premises. Image audit carried out on the estate

n order to help maintain and improve the aesthetics of the West Chester Commercial BID estate, the BID team has carried out an image audit.

Covering all areas of the trading environment, 25 actions were recorded relating to issues with highways, landscaping, general cleanliness, parking, street name plates and fly tipping.

On top of this, the team also met with internal officers at Cheshire West and Chester Council (CWAC) in order to establish the land they own and what their obligations are – known as baseline agreements.

This will be followed throughout the year with further audits which will be reported back to CWAC, to ensure that previously reported issues have been carried out and any potential new issues can be raised.
