An update on image enhancements

he West Chester Commercial BID team is committed to ensuring the cleanliness and appearance of the estate is maintained throughout the year.

As a result, the BID team helps organise and deliver a range of cleaning and maintenance provisions to try and ensure that the BID area is clean, tidy and appealing to visitors and the businesses that work here.

One way in which the BID does this is through monthly audits of the estate. Following these audits, a report is prepared for the Supervisor of Cheshire West and Chester Council's Street Care team and meetings are then held with the Supervisor to work through any issues that may be arising.

Working with the council, the West Chester Commercial BID has also secured a small team to look after and maintain the aesthetics of the estate.

This will see a range of services being carried out at different times each month such as grass cutting, weed control, shrub bed maintenance, hedge cutting, mechanical sweeping to hard surfaces and a pedestrian weekly litter pick.

As well as your BID team looking to pinpoint potential issues, it is important that you notify the council of any problems you discover such as litter, fly tipping and overgrown verges.

You can do this via the 'Your Streets Portal' which can be accessed here: www.westcheshireyourstreets.co.uk.

Once you're on the homepage all you have to do is click the Streetcare Pledge tab and then provide the details of your issue.

By working together we can do our best to try and ensure that West Chester Commercial BID is a great place to work and do business.

Policing on West Chester Commercial BID

he West Chester Commercial BID has a close working partnership with Cheshire Police.

Since the start of the BID in September 2017, we are pleased to announce that the crime figures have reduced.

Security provision increased on the estate

Chester Commercial BID, security has been provided on Bank Holidays and over the Christmas period.

However from this year, and after listening to feedback from businesses, security provision will be increased.

So not only will Bank Holidays and Christmas be covered but now one weekend each month will see a security officer and marked vehicle on the estate.

This will take place on either Friday and Saturday or Saturday and Sunday evenings and each shift will last for 12 hours between 6:00pm and 6:00am.

On top of this the BID will also be providing five extra 12-hour shifts during December to give an extra layer of security when the daylight hours are at their shortest.

Findings from BID customer care visits

t the end of summer 2019, the West Chester BID Officer carried out customer care visits around the estate.

These visits take place to ensure that the BID team has the correct contact details for businesses and that everyone is aware of the different services that the BID provide.

The BID Officer engaged with over 70 businesses and his findings are as follows:

- Businesses are very satisfied with the security, training courses and rapid text service that is provided by the BID.
- The majority of businesses are planning to stay within the West Chester BID area and have forecasted a growth in business over the next 12 months.

- The majority of businesses are pleased with the work that's been carried out by the BID so far.
- A popular request from businesses was the extra provision of security on the estate.
- The main concern for businesses are the hazards caused by the amount of on-road/pavement car parking within the BID areas.
- Not all businesses are aware that the BID has direct links to Cheshire Police and that businesses have access to three PCSOs.
