Theme one	The BID Team continue to work to the emergency action plan for the estate as the country comes out of "lock down".			
Security				
	• The team have spoken to the local PCSO Martin Quick to get any updates or any security issues that the BID need to be aware off. Martin informed the team that they will be on the estate carrying out speed checks to deter the boy racers. Martin also mentioned that the barrier that has now been erected on Dee View has made a big impact and has stopped the cars going on this particular car park, although it seemed to have moved the issue to the retail park. Martin assures me that he will continue to monitor the situation and that he is spending more time patrolling the estate.			
	• Martin again has advised in respect of any issues of ASB if the team can continue to encourage all the businesses to report it to Cheshire Police, this enables them to build up a picture of the current problem. The businesses can report through the '101' system but are better doing it online as there are long waiting times on the telephone. It is better for the Police if all incidents are reported to them to allow them to take things further.			
	• The BID team continue to receive and check the Dyster reports and deal with any other relevant security issues that are raised by Alpha Omega or the businesses. The team continue to have monthly meetings with Alpha Omega and also the PCSO to discuss any security issues and report back to the board. The team have spoken to Alpha Omega and arranged security patrols for the estate over the Christmas holidays. Patrols are booked from 6pm 24th December 2020 through to Monday 4th January 2021			
	• Selecta DNA Property Marking Kits will be distributed to all the new business on the estate (when it is safe to do so) the team will also encourage them to sign up to Rapid Text
