West Chester Commercial BID project updates

espite the disruptions caused by COVID-19, there has still been lots going on in the West Chester Commercial BID area.

Please see below for a summary of the key developments.

New signage

The West Chester Commercial Business Improvement District has agreed to fund three new image enhancement projects over the last year. These will help make the estate a more attractive place for businesses and employees to work, and also make it more accessible to customers and suppliers.

In line with this, the BID approved funding for two large signs to be installed. One will be situated on the land at B&S Group on Sovereign Way and the other is located on land at Bromborough Paints on Bumpers Lane.

Landscape projects

There are another five landscape projects that have been agreed in the action plan and these should be completed within the next few months. They are planned for Jupiter Drive, Sovereign Way, Bumpers Lane, Sealand Road/Bumpers Way and Talbot Way, with the overall aim of improving the aesthetics of the estate for both workers and visitors alike.

CCTV/ANPR

The board has asked for a review of CCTV and ANPR requirements for Sealand Road Industrial Estate and Chester West Employment Park as security is of utmost importance for businesses and their staff.

The aim is to establish the best technical solution for the installation of an estatewide CCTV and ANPR system for the whole West Chester BID area.

Consultants will now be tasked with reviewing the complete area and establishing a system that not only supports with the prevention and detection of crime but, if legally allowed, also links into other stakeholders' solutions.

This could include Cheshire Police, Cheshire West and Chester Council or the businesses that are located on the estate. We will ensure that the proposals provide best value for money and a return on investment for the business community.

Free training courses

The BID team sent out a survey to all businesses to establish their training needs for the coming year. There was a good response to the survey with 26 businesses and 102 of their staff looking to take up the offer of free training provided by the BID. The most popular courses have been First Aid at Work, Health & Safety and a new course added this year called Mental Health First Aid.

Estate maintenance

The schedule for the maintenance of the estate has being ongoing since January. This includes litter picking, mechanical road/ path sweeps and shrub pruning, which are all being carried out on a monthly basis.

The BID team has also put in a request for the Highways team to address the potholes on the estate and, following discussions, the double yellow lines and the white lines at the Quad on Chester West Employment Park are now on Cheshire West and Chester Council's schedule for repainting.

The BID team

The BID team continues to provide support and advice to companies on a day-to-day basis. Topics include growth (secure bigger premises), advertising jobs, traffic management, inter-trading opportunities, sharing CVs for employees who are under threat of redundancy and checking availability of grants for businesses. With Coronavirus restrictions having now eased somewhat, we will be looking to do more face-to-face engagement in the near future.
